NOW, THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:

1: CO-OPERATION:

- 1.1 Both Parties are united by common interests and objectives, and they shall establish cooperation
- 1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities
- 1.3 The Parties shall co-operate with each other and shall as promptly as is responsibly practical, relevant agreement.

2: SCOPE OF THE MOU

- 2.1 Guest Lectures: Second Party to extend the necessary support to deliver guest lectures to the students of the first party on the technology trends and in-house requirements
- 2.2 Certificate Courses: The Second Party will actively engage to help the delivery of certificate courses in the field of Civil Industries based on the industry-leading platforms to the students of the first party.
- 2.3 Internship for students: The Second Party will actively engage to help the delivery of the training and internship to the students of the first Party on the technology trends and inhouse requirements
